- 7.3.2 and no bid will be accepted by the auctioneer from either of the aforesaid persons,
- 7.3.3 should the above provisions not be adhered to than the consumer may approach a court of law declaring the transaction fraudulent,
- 7.4 THE RULES OF AUCTION COMPLY WITH SECTION 45 OF THE CONSUMER PROTECTION ACT 68 OF 2008 (HEREIN AFTER REFERRED TO AS THE "ACT").
- 7.5 THE WORD "**AUCTION**" INCULDES SALES IN EXECUTION OF /OR PURSUANT TO COURT ORDERS, TO THE EXTENT THAT SAME CONTEMPLATES THAT THE SALE IS TO BE CONDUCTED BY AUCTION.
- 7.6 GOOD S SOLD AS LOTS ARE REGARDED AS SEPARATE TRANSACTIONS UNLESS THE CONTRARY APPLIES.
- 7.7 THE AUCTION WILL TERMINATE ON THE OCCURRENCE OF EITHER OF THE FOLLOWING:-
 - 7.7.1 by the auctioneer announcing the termination of the auction; or
 - 7.7.2 by the fall of the hammer; or
 - 7.7.3 by any such customary method

(until which point any bid may be retracted).

ORDER TO BID.



- 7.10 ALL BIDDERS AND PROSPECTIVE BIDDERS MUST PRIOR TO BIDDING, REGISTER WITH THE BIDDERS RECORD, BY INSERTING HIS / HER NAME AND IDENTITY NUMBER THEREIN.
- 7.11 THE BIDDERS RECORD AND VENDORS ROLL WILL BE AVAILABLE FOR INSPECTION DURING NORMAL BUSINESS HOURS. NO FEE WILL BE CHARGED FOR THE INSPECTION OF THE SAME.
- 7.11 AUCOR HAS A TRUST ACCOUNT, INTO WHICH ALL MONIES WILL BE PAID TO FOR THE BENEFIT OF THE SELLER MINUS ANY AGREED COMMISSION.

9. <u>SPECIFIC RULES RELATING TO THE AUCTIONEER:</u>

- 9.1 Any amendments made to the rules of auction will be announced verbally by the auctioneer at the auction.
- 9.2 Should the auctioneer who signed these rules be unable to conduct the auction for any reason whatsoever than the person who conducts the auction is deemed to have certified the rules of auction.



9.3 The auctioneer is personally liable for the contents of the rules of the auction applicable to the specific auction.

- in the case of a closed auction the information was made available to the closed list of persons at the auction.
- at the auction(with the exclusion of internet auctions), the auctioneer invites any person present at the said auction to object and no one does.
